Due to retirement, the **City of Clinton**, North Carolina, operating under a Council-Manager form of government, is seeking a **Police Chief** who appreciates small town culture, enjoys engaging the community, and has a demonstrated history of innovative leadership. The Clinton Police Department is a full-service law enforcement agency that is recognized by CALEA and has a reputation as a highly responsive department with staff who are an active part of the community. The successful candidate will have a track record of strategic and collaborative leadership. **Position Description and Responsibilities:** Reporting to the City Manager, the Police Chief is responsible for planning, directing, implementing, and evaluating the activities of a CALEA accredited Police Department. The Police Chief will be responsible for leading a Department in a community of 8,800 citizens that expect high levels of service and engagement. The Department has a \$2.3 Million Budget, 28 fulltime sworn personnel, and four civilian personnel. The ideal candidate will be a strong leader who will work well with Elected Officials, the City's Management Team, community members, and surrounding law enforcement agencies, and will be experienced and confident in managing all areas of a full-service police department. <http://www.cityofclintonnc.com/services/police/index.php>. **Qualifications and Pay:** Requires a Bachelor's Degree in criminal justice, public administration, or other relevant field, and fifteen (15) years of progressive law enforcement experience to include five (5) years of command level experience at the minimum rank of Lieutenant; or any equivalent combination of training and experience that provides the required knowledge, skills, and abilities of a law enforcement executive. Master's Degree and Advanced Law Enforcement Training preferred. Must have a valid NC driver's license or the ability to obtain a valid NC driver's license within 60 days of hire. Must have current certification as a municipal or local government law enforcement officer by his/her respective state or with no more than one year break in full-time sworn service at time of appointment. North Carolina law **does not** recognize **nor** have a reciprocal relationship with Federal law enforcement certification but does recognize and give partial credit for military police (MP) training, receipt of a MP occupational specialty classification, and performance of MP duties.
