

## JUNE 2, 2009 CITY COUNCIL MEETING

The City Council of the City of Clinton, North Carolina, met in regular session at 7:00 PM on June 2, 2009, in the City Hall Auditorium. Mayor Starling presided. Councilmembers Becton, Harris, Stefanovich, Strickland, and Turlington were present. The city attorney Dale Johnson; city clerk Elaine F. Hunt; city manager John F. Connet; assistant city manager Shawn Purvis; finance director Betty Brewer; interim fire chief Todd Solice; planning and community development director Jeff Vreugdenhil; senior planner Mary Rose; recreation director Judi Nicholson; public works director Chris Doherty; human resource manager Lisa Carter; and police chief Mike Brim were present.

Rev. Ron Cava, Pastor of First Baptist Church, 408 College Street, Clinton, NC, gave the invocation.

### **CITY COUNCIL**

Upon a motion made by Councilmember Stefanovich, seconded by Councilmember Becton, the minutes of the May 5, 2009 regular city council meeting and May 19, and May 28, 2009 special city council meetings were approved unanimously.

### **PRESENTATION**

Mayor Starling welcomed Jerry Bradshaw, of the Sampson County Sheriff Department to the group. He asked Mr. Bradshaw to brief City Council regarding an upcoming event.

Mr. Jerry Bradshaw told City Council about an annual event known as the "Trinity Children Annual Charity Ride". He stated that it will be a three-day ride beginning on June 18, and ending June 20, 2009. He further introduced the founder of this non-profit organization, Ms. Doris Eakes.

Ms. Doris Eakes gave the origin of the Trinity Children Foundation. She stated that its mission is to address the needs of abused and neglected children. Ms. Eakes stated that this charity ride started with seven riders. She stated that they have a strong support from this area and the money will stay in North Carolina. Before concluding, Ms. Eakes presented Mayor and City Council with patches, pins, and bandannas.

Mayor Starling read and presented the following resolution to Ms. Eakes, Jerry Bradshaw, and other supporters:

### **RESOLUTION OF RECOGNITION TRINITY CHILDREN ANNUAL CHARITY RIDE**

***WHEREAS*, the Trinity Children Foundation will be celebrating its 4<sup>th</sup> Annual Charity Ride beginning June 18, 2009 in Maggie Valley, NC and ending on June 20, 2009 in Carolina Beach, NC; and**

**WHEREAS**, the mission of the Trinity Children Foundation is to enhance and address the needs of abused and neglected children around the world by providing food, clothing, shelter, health care, and emotional stability; and

**WHEREAS**, this volunteer, non-profit organization was formed in 2005 by Doris W. Eakes, who in 2006 hosted her first fundraiser, the Trinity Children Charity Ride, in which 32 motorcyclists rode from Kure Beach, NC to Townsend, Tennessee; and

**WHEREAS**, this year's Trinity Children Annual Charity Ride will consist of approximately 75 motorcyclists—26 local riders from Sampson and Bladen Counties; and

**WHEREAS**, the riders of this year's charity ride will travel through our very fine city of Clinton, North Carolina on June 20, 2009.

**NOW, THEREFORE BE IT RESOLVED**, that the Mayor and City Council of the City of Clinton, North Carolina express gratitude and appreciation to Doris W. Eakes and the Trinity Children Foundation for their commitment to the abused, neglected, and underprivileged children of North Carolina.

**BE IT FURTHER RESOLVED** that this resolution be spread upon the minutes of the City Council.

### **RECOGNITION**

City Manager Connet introduced Eli Turlington to City Council and the public. He stated that Eli received his Eagle Scout Award on May 10, 2009. Mayor Starling presented him with a certificate of commendation upon receiving this prestigious Eagle Scout designation.

### **APPEARANCE**

Jeff Warren appeared before City Council to give an update on the Sampson Community Theatre. He showed a PowerPoint and presented figures to City Council for repairs and utilities of the theatre beginning FY 2005-2006 totaling \$14,144; FY2006-2007 totaling \$10,811.84; and FY2007-2008 totaling approximately \$36,501.00.

Mr. Warren stated that the fire sprinkler system was inspected recently and passed. He stated that a stop work order has been served on the building from the Sampson County Emergency Management. He further stated a fire door, an exit door in front of the stage, and wiring need to be completed. An engineer has been contacted to get a quote for the work needed and he is waiting to hear back from the engineer.

Mayor Starling thanked him for his very informative update of the Sampson Community Theatre.

## **P & Z – 403 SOUTHEAST BLVD – MIDNITE RODEO OF CLINTON, LLC**

Mayor Starling opened and closed a public hearing on a request by Paul Scoggins of Midnite Rodeo of Clinton, LLC for a conditional use permit to operate an entertainment facility at 403 Southeast Boulevard, in an HC Highway Commercial district.

This public hearing was continued until 7:00 PM on July 7, 2009.

### **BUDGET**

Mayor Starling opened a public hearing to receive input on the 2009-2010 Fiscal Year Budget.

City Manager Connet began by briefing City Council on the City of Clinton's 2008-2009 Accomplishments which included: NC Main Street Award for Best Public/Private Partnership; Police Department CALEA Recognition; Stetson Street and Carolina Avenue drainage improvements; Phase II of Sampson Center Revitalization Project; Dollar Branch Sanitary Sewer Replacement Project; NC 403 Gravity Sewer Project; and 2009 All-America City Finalist. City Manager Connet reviewed the budget. He stated the budget for FY2009-2010 totals \$13,100,401 for all City operations, capital improvements, and debt service requirements, which is a decrease of \$781,582 or 5.63% from the FY 2008-2009 Amended Budget.

City Manager Connet stated City Council's Goals and Objectives for this upcoming year: (1) sustain a clean and beautiful city (2) provide clean and safe neighborhoods, and (3) construct and maintain sound infrastructure.

City Manager Connet gave highlights of the proposed FY2009-2010 General Fund Budget. He stated the overall proposed budget in general fund for FY 2009-2010 totals \$8,505,970. He stated that this proposed budget has been reduced by \$739,308 or 7.95%. He further stated that the largest portion of General Fund goes to public safety.

City Manager Connet gave personnel highlights to include: two full-time positions have been proposed, no raises, the City's funded medical reimbursement to employees will be converted to a funded health savings account, and medical insurance is still being negotiated.

He gave capital outlay highlights to include: street resurfacing, garage service vehicle, small pickup truck for Cemetery Department, 3 police vehicles, residential garbage truck, HVAC replacement totaling approximately \$40,000, and Royal Lane Park improvements. City Manager Connet gave revenue highlights to include: proposed recreation sports registration fee for city residents at \$10.00 per child/per sport, residential solid waste fee increase from \$12.20 to \$12.35, increased cost of cemetery plot at Sandhill Cemetery from \$145 to \$150, and no increase in commercial solid waste fee. It was further mentioned that the proposed recreation sports registration fee for city residents at \$10.00 per child/per sport came as a recommendation from the Recreation Advisory Board.

City Manager Connet continued with reviewing the Water and Sewer Fund highlights which included: total budget proposed - \$4,520,536, 0.85% reduction from FY2008-2009, filter media replacement, Russell Street CDBG Project, construction of new treated water tank at WTP, water tank maintenance, and backup generator for high school well. He stated that small increases are being proposed in water and sewer rates. He concluded his presentation with a chart showing the Fund Balance – Unreserved General Fund Balance – for June 30, 2009 and stated that he is very proud of the financial condition of the City of Clinton.

City Council had previously reviewed the budget at two work sessions on May 19, and 28, 2009. No one else wished to be heard, and the hearing was closed.

Mayor Starling stated that no action will be taken tonight; however, City Council is asked to adopt the budget on June 23, 2009 at 7:00 PM.

### **APPOINTMENTS**

Upon a motion made by Councilmember Turlington, seconded by Councilmember Becton, Albert Kirby, Michael Carter, and Debbie Roberts were unanimously appointed to fill the expired four-year terms of Frank Butler, Eugene Vaught, Jr., and Joel W. Rose on the Historic Preservation Commission. Mr. Kirby, Mr. Carter, and Ms. Roberts' terms will expire June 2013.

Notification was given of the expiring three-year term of Shurley McCullen on the ABC Board.

### **CITY CODE -- ORDINANCE-- EXCAVATING**

Assistant City Manager Purvis stated that Recreation and Parks Director Judi Nicholson has requested that City Code Chapter 18, Section 18-58 be revised to cover use of metal detectors in the parks. He stated that in a memo, she stated that they have had a number of incidents involving people bringing metal detectors to the park and going through the playgrounds, ball fields, and picnic areas looking for change and jewelry. City Manager Connet stated the revision of this City Code would prohibit people from digging on the grounds.

Upon a motion made by Councilmember Stefanovich, seconded by Councilmember Becton, the following ordinance was unanimously adopted:

#### **Ordinance # 2009.06.01**

**BE IT ORDAINED** by the City Council of the City of Clinton, North Carolina that Chapter 18, Section 18-58. Excavating of the Clinton City Code of 1987 is hereby amended to read as follows:

Sec. 18-58. Excavating and metal detecting on city property.

It shall be unlawful for any person to make an excavation in any recreation area for any purpose without written permission from the recreation department or its designated official.

It shall be unlawful for any person to possess or use a metal detector or probe to search for objects in, on or below the surface of the soil or make an excavation in any park or recreation area for any purpose except in the following situations:

1. When using the metal detector or doing excavation while under contract by the City for purposes related to the completion of work as approved by the city.
2. Permission may be granted by the recreation department or its designated official for a metal detector to be used at a specifically identified park or recreation area to locate and recover a specific item of personal property which has been lost by the person requesting such permission.

This ordinance does not apply to activities conducted by city employees during the course of their duties for the city.

### **RESOLUTION – CONDEMNATION -- COLLEGE STREET PARKING LOT**

City Manager Connet asked City Council to adopt a resolution authorizing the City of Clinton to condemn property. He stated that in order to proceed with the acquisition of the College Street parking lot, the City must adopt this resolution to move forward with the friendly condemnation process. He further stated that due to the fact that Councilmember Jean Turlington has an ownership stake in this property, she will have to be excused from voting upon this item.

Upon a motion made by Councilmember Becton, seconded by Councilmember Strickland, Councilmember Turlington was recused from voting upon this item.

Upon a motion made by Councilmember Stefanovich, seconded by Councilmember Harris, the following resolution was unanimously adopted with Councilmember Turlington not participating in the vote:

### **RESOLUTION AUTHORIZING THE CITY OF CLINTON TO CONDEMN PROPERTY**

WHEREAS, the City of Clinton needs and desires to purchase property located and used as a public parking lot in downtown Clinton, and currently owned by Selma C. (Jean) Turlington, Ann Turlington and Hiram Lodge No. 98 A.F. & A. M., and more particularly described as follows:

BEING all of those certain tracts or parcels of land lying and being located in North Clinton Township, Sampson County, North Carolina, and being more particularly described as follows:

TRACT NO. 1: A certain lot or parcel of land, lying and being in the City of Clinton, North Clinton Township, Sampson County, North Carolina, adjoining the lands of Mrs. Anna Wooten and others, and situated at the junction of Main and College Street in said City of Clinton, and known as Lots Nos. 18 & 19 as shown on the plat showing a re-subdivision of the old Clinton Hotel property made by L.E. Whitfield, E.E., and duly recorded in Plat Book 1, Page 21, Records of Sampson County, to which plat reference is hereby made, said two lots showing a frontage of 159 feet on College Street, 119 feet on Main Street and 95 feet on the back line, with the exception of a ten feet alleyway opening into Main Street, a depth of 40 feet across the entire width of Lot No. 18 at rear end.

For title history, see Deed Book 454, Page 113, Sampson County Registry.

TRACT NO. 2: BEING all of Lots 20, 21, 22 and 23 of the Old Clinton Hotel Property Re-Subdivision, according to a survey and plat thereof, which plat is duly recorded in Plat Book 1, Page 21, of the Sampson County Registry, to which plat reference is made for a more particular description.

For title history, see Deed Book 1724, Page 89 (Tract No. 1) and Deed Book 1579, Page 715 (Tract No. 21), both of the Sampson County Registry.

WHEREAS, the City of Clinton desires to own, manage, upgrade and update this public parking in conformity with the City of Clinton downtown beautification program; and

WHEREAS, all parties have agreed on the purchase price of \$62,500, to be divided as follows:

- (a) To Selma C. (Jean) Turlington, the sum of \$17,500;
- (b) To Ann Turlington, the sum of \$17,500;
- (c) To Hiram Lodge No. 98 A.F. & A.M., the sum of \$27,500; and

WHEREAS, all parties have agreed to a friendly condemnation procedure for the City of Clinton to acquire title to the above described property.

NOW, THEREFORE, BE IT RESOLVED that John F. Connet, City Manager, and Dale P. Johnson, attorney for the City of Clinton, are authorized to proceed with the purchase of the above described property.

### **CONDEMNATION – 304 Barden Street**

Planning and Zoning Director Jeff Vreugdenhil spoke regarding an ordinance of condemnation for 304 Barden Street. This item was continued from the April 7, 2009 city council meeting. Mr. Vreugdenhil stated that there has been much improvement to this property and asked that this item be continued.

This item, consideration of an ordinance of condemnation was continued until the July 7, 2009 city council meeting.
