New Sidewalks in the City by Jeff Vreugdenhil, Public Works Director

The City adopted the Clinton Comprehensive Pedestrian Plan in 2012 to promote pedestrian safety and guide pedestrian improvements and connectivity throughout the city. The plan recommends construction of 36 new sidewalks or greenways. This summer, the city completed its first sidewalk project identified in the plan, and two others will soon follow with help from the NC Department of Transportation (NCDOT). The new sidewalk along Barden St. allows pedestrians to walk safely from Fayetteville Street to Dogwood Circle and then to the walking trail at the Sampson Center. Residents in the neighborhood indicated these sidewalks as a top priority at the 2015 District 5 Meeting, as well as past district meetings.

In the upcoming months, the city will be partnering to construct and repair sidewalks in order to connect Butler Avenue and Sunset Avenue Schools. NCDOT plans to begin this project in early spring 2016. The biggest sidewalk project, and one of the top priorities in the Clinton Pedestrian Plan, will be the construction of sidewalks along both sides of Sunset Avenue from Sampson Community College to the 421/701 bypass with the Highway 24 Project. This will allow pedestrians to access the west and east sides of the city safely while connecting commercial and residential areas.

Thanks to sponsorships by local banks, city planning staff was able to participate in a recent two-day seminar focused on business recruitment and feasibility assessment. Downtown professionals from across the state gathered in Statesville to learn from economist and author Donovan Rypkema, who guided participants through the process of assessing a historic property and preparing a report that could be “taken to the bank.” During the seminar, teams conducted feasibility studies and prepared presentations for various historic properties in downtown Statesville. The project required teams to meet with local bankers, realtors, government officials, and development officials to assess current market conditions,

check land records for important details, and walk through a process to mitigate unknown variables inherent in preservation work. Receiving training on feasibility analysis will help city staff work with various committees and boards to define objectives, identify the constraints and opportunities, and objectively reach a conclusion about the feasibility of proposed projects in Downtown Clinton.

Congratulations, to City of Clinton employees! For a second year, the NC Department of Labor (NCDOL) has recognized City departments for safety practices. On June 9, 2015, the NCDOL sponsored a banquet at the Agri-expo Center to recognize local organizations for achieving safety practices. Organizations can qualify for silver, gold, or million-hour awards based on achieving specific workers compensation loss rates below the industry rate. Loss rates of less than 50 percent of the industry rate qualify for gold level awards. This year, six departments received awards. The Street and Sanitation Divisions as well as the City of Clinton overall received 1st Year Silver Awards. The Fire Department, Recreation, and Water & Sewer Division received 1st Year Gold Awards, and Wastewater Treatment received a 2nd Year Gold Award. We applaud these departments for their outstanding safety accomplishments and hard work and give special thanks to the City’s Health and Safety Committee. These awards demonstrate the City’s commitment to providing a safe place to work and to being responsible with public resources.
