VENDOR PRIVILEGE AGREEMENT

The City of Clinton, North Carolina, Recreation and Parks Department hereby assigns limited Vendor/Concession privilege rights at Royal Lane Park on, _____, **2025**, to _____, **2025** for the period of **5:30 p.m.** through _____ at a charge of **\$50.00** per month payable before the event or at the beginning of the month (depending on the event/program).

“Vendor/Concession Agreement should be present on park during the above time.”

***NO FIRE WORKS OR POPPERS ARE TO BE SOLD ON CITY PROPERTY!**

Vendors shall provide a reasonable service of concession goods at an economical price at this park. The concessionaire shall keep the concessions open for business on the same schedule as the Clinton Recreation & Parks Department schedules.

Vendor shall hold the City of Clinton harmless for all losses incurred in this operation.

That Vendor shall have the use of a designated area, which will be issued by the Clinton Recreation & Parks Department only. The Vendor shall be informed of this area prior to usage. The Vendor will furnish and maintain all loose and portable equipment.

That Vendor will provide a reasonable clean up of trash within a 75-foot circle of the concession stand or vehicle when each period of sales is finished. Trash containers will be provided by the City of Clinton.

That the City of Clinton shall provide a reasonable parking location for a concession vehicle. (Not parking place for vehicle). **Vendors must provide their own electrical power as well as extension cords if desired.**

That the City of Clinton will require that all persons working in the concession stand or vehicle shall be at least sixteen (16) years old and that one adult be present in the stand at all times.

That concessionaire agrees to operate a clean and orderly business in accordance with the regulations and requirements of the Board of Health of the State of North Carolina and in accordance with law. The concessionaire abides by the attached special conditions.
